This Warranty is in lieu of all other warranties, expressed or implied, including without limitation the implied warranties of merchantability and fitness for a particular purpose. CityScapes shall not be liable for any incidental or consequential damages resulting from the use or inability to use the Product, including but not limited to, damages for loss of profits, loss of goodwill, or any other commercial or economic losses.

THE SEVERITY OF THESE CONDITIONS DEPENDS ON AIR QUALITY, THE GEOGRAPHIC LOCATION OF THE PROPERTY AND OTHER LOCAL CONDITIONS OVER WHICH CITYSCAPES HAS NO CONTROL.
